



Please read all of the information carefully before taking this medical device for the first time.

- Keep it in a safe place, as you might want to read it again later.
- If you have further questions, contact your physician, therapist or pharmacist or contact the manufacturer FROXIMUN AG directly.
- This is an over-the-counter medical device that does not require a prescription.

1. What is TOXAPREVENT® MEDI AKUT and what is it used for?

TOXAPREVENT® MEDI AKUT in capsule form is a natural medical device that contains the mineral constituent MANC®, a natural zeolite clinoptilolite, and added colostrum. It is used to strengthen the intestinal wall barrier during recurrent physical stress. The active substance MANC® passes through the digestive tract, does its physical work and is not metabolized.

2. What do you need to know about TOXAPREVENT® MEDI AKUT before taking it?

- Remove the capsules from the blister pack immediately before use.
- Remove only the number of capsules you wish to use immediately.

TOXAPREVENT® MEDI AKUT must not be taken in the following cases:

- If you have a known allergy or sensitivity to one or more constituents (see point 6: contents and constituents).
- Due to a lack of sufficient studies on pregnant women and nursing mothers, you should not take TOXAPREVENT® medical devices when you are pregnant or nursing.

Particular caution should be exercised when taking TOXAPREVENT® MEDI AKUT in the following cases:

- In rare cases, taking TOXAPREVENT® MEDI AKUT in capsule form can lead to constipation or bloating (rare: this may affect 1 in 1000 persons using it).
- If you suffer from chronic constipation, you should use particular caution when taking TOXAPREVENT® MEDI AKUT in capsule form. In such cases, consult your physician, therapist or pharmacist before taking it.
- Always make sure that you drink enough liquid when you take TOXAPREVENT® MEDI AKUT in capsule form in order to prevent constipation.
- As there is not enough empirical evidence on the use of TOXAPREVENT® MEDI AKUT by children, the use of this medical device is not recommended for children under 12 years of age.

If you take medications as well as TOXAPREVENT® MEDI AKUT:

To prevent adverse interactions with medications, you should always maintain a period of two hours between taking medications and taking TOXAPREVENT® MEDI AKUT in capsule form, as there are no systematic studies on interactions with or influences on medications when taken with TOXAPREVENT® MEDI AKUT in capsule form. If you take medication, consult your physician or therapist regarding the waiting time between taking TOXAPREVENT® MEDI AKUT and your medication.

3. How should TOXAPREVENT® MEDI AKUT be taken?

- Unless otherwise specified by your physician or therapist, take 1 - 2 capsules TOXAPREVENT® MEDI AKUT 30 minutes before each meal up to three times daily with plenty of liquid, (e.g at least 200 ml non-carbonated water).
- Do not exceed the specified daily dose of 6 capsules.
- If you experience sustained side effects, stop taking this product and consult your physician or therapist.

Duration of use

The duration of treatment with TOXAPREVENT® MEDI AKUT should not exceed 30 days. Should you wish to repeat the treatment, you should pause for at least one week before starting treatment again.

Countermeasures in the event of errors in use, overdoses and side effects

If you inadvertently take a dose larger than the dose specified in these instructions for use, you may experience more severe side effects. In this case, the dose of TOXAPREVENT® MEDI AKUT should be reduced to one capsule before every meal and the liquid increased to at least 300 ml. If you experience sustained side effects, stop taking this product and consult your physician or therapist.

4. What are the known side effects?

In rare cases, taking TOXAPREVENT® MEDI AKUT in capsule form can lead to constipation or bloating (rare: this may affect 1 in 1000 persons using it).

Reporting side effects

If one of the listed side effects causes you considerable difficulty or you notice side effects that are not listed in these instructions for use, please inform your physician, therapist, pharmacist and/or send a message to the e-mail address of FROXIMUN AG listed below or contact us via one of the customer service numbers likewise listed below.
